- » 81% of banking executives consider RTP to be a priority

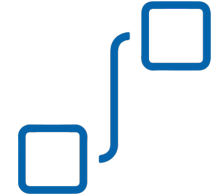

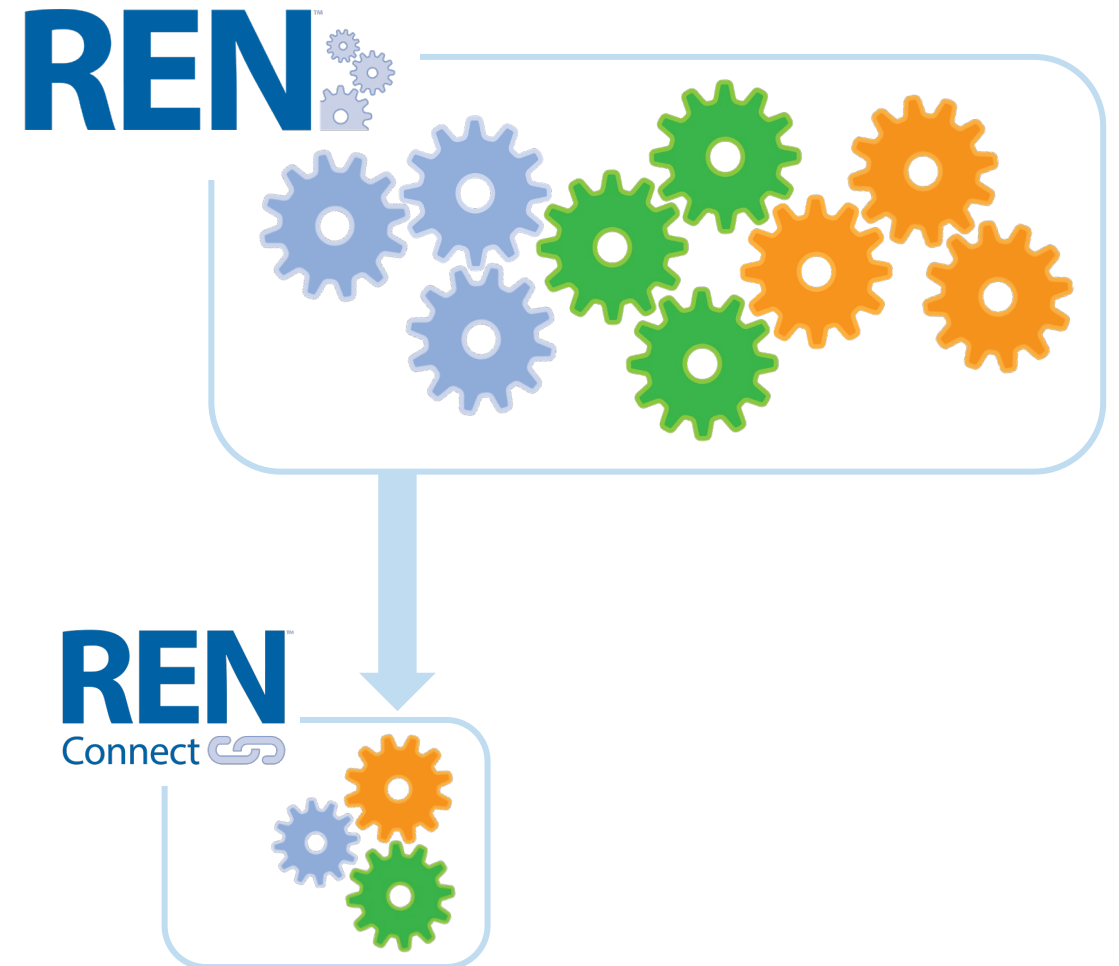

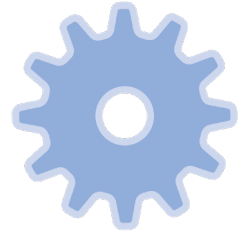

To help financial institutions quickly and easily join the RTP networks in their countries, **REN Connect** uses three technologies from the modular architecture of **REN**.

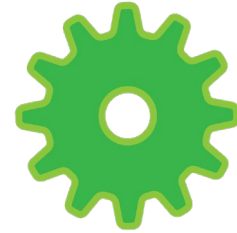


Three REN Modules: Fast and Easy RTP Connections



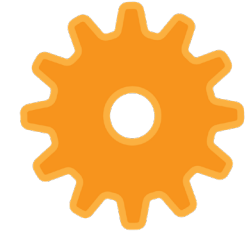
REN API Gateway

The Gateway is how data enters and exits REN Connect on the way to and from an RTP Clearing House



REN Data Transformer

The Data Transformer matches any incoming message format to outgoing message formats



Real Time Payment Service

Pre-configured by Euronet, this module manages rules, timers, limits, and other elements of an RTP system

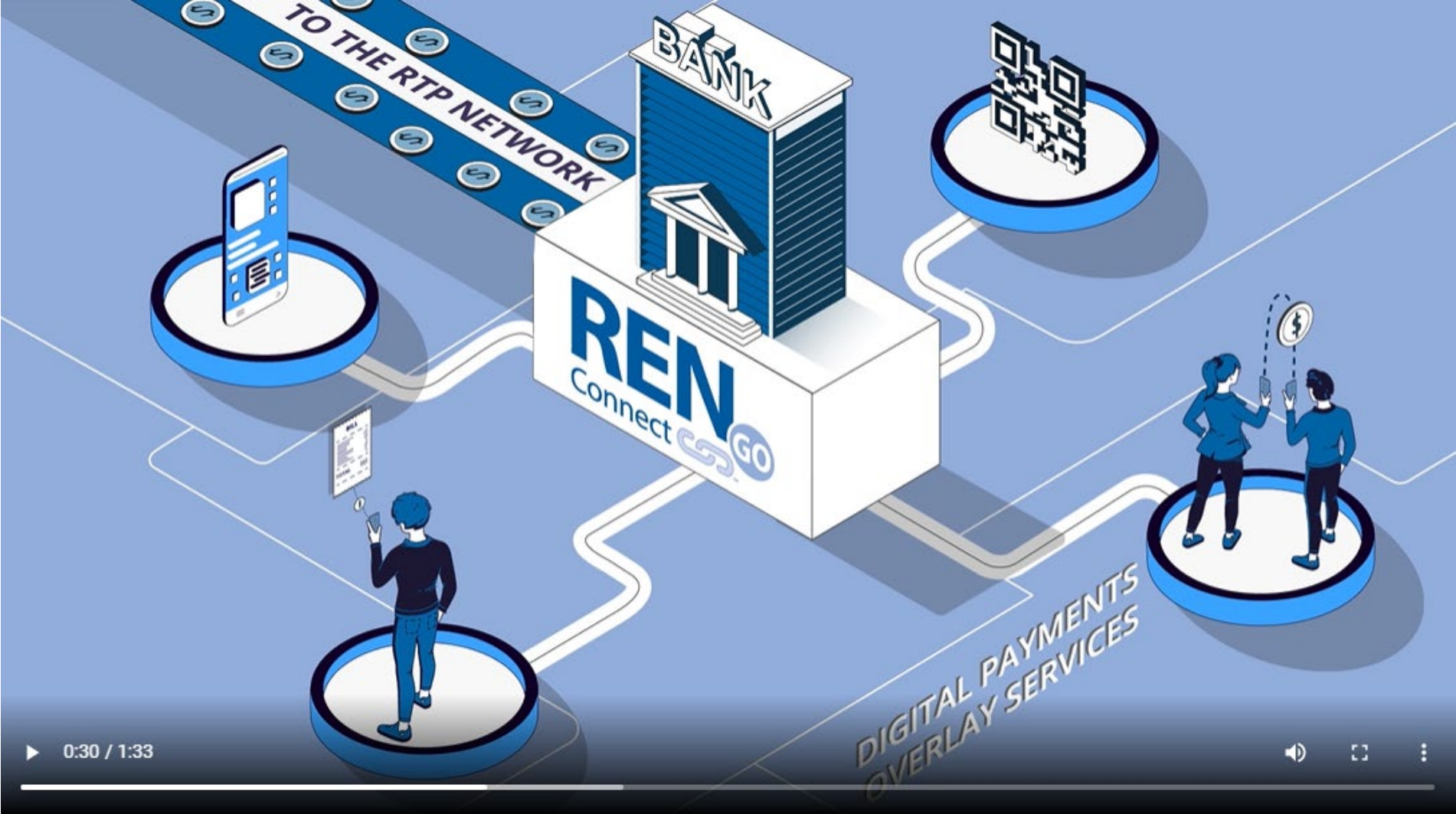


Euronet's **REN Connect Go** includes tools a financial institution uses to build customer-facing apps or websites/portals that leverage the RTP connections provided by REN Connect.
